MESSAGE FROM THE CEO

INSPIRATION AND INNOVATION

As the COVID-19 pandemic continues to evolve, the ACCME is working to evolve alongside our accredited providers to meet the changing needs of our learners. Although the past few years have restricted our ability to interact in person, we, as a continuing education community, have strengthened our connections and collegiality, supporting and caring for each other. I remain inspired by the compassion, resilience, and innovative spirit of our accredited providers—you continue to adapt and respond to the needs of clinicians and healthcare teams, offering timely, quality accredited education in diverse learning environments.

When the pandemic began, we recognized that our responsibility was to serve as a facilitator, offering accredited providers the guidance, resources, and flexibility that would enable you to meet the needs of healthcare professionals during extraordinary times. From the ACCME virtual annual meetings to the newly expanded ACCME Academy—our goal is to offer resources that enable educators to advance their professional development and rise to the challenges of an ever-changing healthcare landscape. Together, we are building our community of practice, nurturing collaboration, promoting growth, and demonstrating how accredited education makes a meaningful difference in the lives of clinicians and patients.

In this report, we share with you the key initiatives we've undertaken to respond to your recommendations, fulfill our strategic goals, and support our shared mission to improve care for patients and communities:

 Throughout the pandemic, we, along with our colleagues in Joint Accreditation for Interprofessional Continuing Education[™], offered new accommodations and resources to help the accredited education community adapt to new circumstances. We provided an expedited pathway for planning activities related to COVID-19, a searchable database for vaccine-related education, and guidance for transitioning to virtual learning formats. Working with our colleague accreditors in the health professions, providers, and other stakeholders, we released the Standards for Integrity and Independence in Accredited Continuing Education. With these Standards, we deliver on our promise to healthcare professionals that they can trust accredited continuing education to provide accurate, balanced, evidence-based information that supports high-quality patient care.

- To meet the needs of our accredited providers, physicians, regulatory bodies, and other stakeholders, we developed an upgraded version of the Program and Activity Reporting System (PARS). Providers can now enter, track, and manage learner data for all accredited activities. In conjunction with the new PARS, we launched CME Passport, a free, all-in-one web application that enables physicians to find, track, and manage their CME.
- We continue to expand our collaborations with our colleague regulatory bodies, with the goal of reducing CME-reporting burdens for physicians, giving them more time to focus on their education and patient care, rather than on compliance.
- As part of our commitment to fostering learning environments

that promote diversity, health equity, and inclusiveness, our Board of Directors convened a special task force to explore how we can facilitate meaningful change and advance these ideals in accredited education. The Board of Directors will share their findings in 2022.

In the coming year, the ACCME will work to build our strategic plan and vision for the coming years, continuing our upward trajectory. I look forward to working together to promote an even more dynamic system that adapts to the changing expectations of learners today and in the years to come.

More than ever, I believe that accredited education has the capacity to be a part of the solution to the challenges we face. My colleagues at the ACCME and I want to thank our providers, educators, and healthcare professionals who continue to show us the ability of education to make the world a better, healthier place.


OUR COMMUNITY

Our community of approximately 1,700 CME providers represents a range of organizations from national physician membership organizations to rural hospitals. Some specialize in local, community-based health issues, others focus on national and international health priorities, and others advance interprofessional continuing education (IPCE) and team-based care.

The geographic distribution and diversity of CME providers means that clinicians and teams have access to education where they live and work that addresses local, national, and international healthcare priorities.

A RESILIENT, RESPONSIVE COMMUNITY

In March 2020, the World Health Organization declared the COVID-19 outbreak a global pandemic. Since then, the accredited education community has adapted nimbly, creating new learning environments to deliver critically needed skills and support to clinicians and healthcare teams. We at the ACCME strive to provide the best possible support for the accredited education community, particularly during times of uncertainty. During this time, we offered the following accommodations and resources:

- Expedited pathway for planning accredited activities related to COVID-19 to help accredited providers meet the urgent need for education.
- LearnToVaccinate.org: A searchable database of accredited continuing education activities related to the COVID-19 vaccines, featuring 120 activities—one of our most highly viewed pages.
- Resource pages for clinicians and educators including information on administering the COVID-19 vaccines.
- Survey of accredited providers, including several interviews, on how the pandemic is affecting the accredited education community.
- Best practices for creating a virtual meeting for planners and educators.
- Sample run-of-show documents and staff training plans from the virtual ACCME 2020 Meeting.
- LinkedIn articles and podcasts addressing vaccine hesitancy in healthcare professionals, ways to combat learner fatigue, and evolving CME amid the pandemic.


STRATEGIC GOAL 2:

ASSURE ACCREDITATION QUALITY AND EQUIVALENCY

ACCME Standards for Integrity and Independence in Accredited Continuing Education

In December 2020, we released the <u>Standards for Integrity and Independence in Accredited Continuing Education</u>, replacing the Standards for Commercial Support: Standards to Ensure Independence in CME Activities. The Standards are designed to ensure that accredited continuing education provides healthcare professionals with accurate, balanced, evidence-based information that supports safe and effective patient care.

The newly evolved Standards reflect the values of the accredited education community and have been adopted by the following accrediting bodies representing multiple health professions:

Our Colleague Accreditors

We appreciate the collaborative efforts and dedication of our colleague accreditors, whose work supports local CME providers such as community hospitals, state specialty societies, and county medical societies. The COVID-19 pandemic emphasized the value of local accredited education in providing necessary resources and support for clinicians and healthcare teams—thank you for your hard work during an uncertain time.

Using a framework of equivalency, we recognize 35 state and territory medical societies as accreditors of regional and local CME programs. Equivalency ensures that all CME providers in our system, whether they are ACCME-accredited or state-accredited, are held to the same high standards for educational excellence and independence.

We provide ongoing education, auditing, feedback, support, and IT solutions to Recognized Accreditors at no cost, as part of our commitment to sustaining a vibrant state-accreditation CME system. Resources include the ACCME Academy, monthly webinars, support for staff in transition, and volunteer training.

An International, Interprofessional Community

As a founding member of the International Academy for CPD Accreditation (IACPDA), we work with our colleagues around the world to harmonize standards to increase opportunities for clinicians to engage in high-quality education.

In 2020, the IACPDA announced the adoption of the <u>Standards for</u> <u>Substantive Equivalency between CPD/CME Accreditation Systems</u>, the first Standards to set international guidelines for the accreditation of continuing professional development. The Standards are designed to support improvements in patient care and patient safety by promoting high-quality continuing education for medical doctors and teams across borders. They will be used to determine substantive equivalency between accrediting bodies.

The ACCME recognizes six accrediting bodies outside the US as substantially equivalent to the ACCME's accreditation system:

- Committee on Accreditation of Continuing Medical Education (Canada)
- European Board for Accreditation of Continuing Education for Health Professionals (EBAC)
- Federation of the German Chambers of Physicians
- Royal College of Physicians and Surgeons of Canada
- Oman Medical Specialty Board
- Accreditation Section of the Department of Healthcare Professions of the Qatar Ministry of Public Health

Accreditation with Commendation

Congratulations to the CME providers that have implemented the Menu of Criteria for Accreditation with Commendation! Since the menu went into effect in 2017, 45 providers achieved Accreditation with Commendation. All provider types have applied for and achieved commendation.

Serving as a guidepost for the future of CME, the commendation menu rewards and recognizes providers for leveraging the power of education to:

- Promote team-based education
- Address public health priorities
- Enhance skills
- Demonstrate educational leadership
- Achieve outcomes

Our collaborations with certifying boards continue to streamline processes for CME providers, drive innovation and flexibility in education, expand lifelong learning options, and reduce burdens for physicians. We were pleased to welcome the American Board of Surgery to our collaboration in 2020. We now have collaborations with seven certifying boards.

Advancing Healthcare Education by the Team, for the Team

In 2020, we were proud to celebrate the 10th anniversary of Joint Accreditation for Interprofessional Continuing Education, the first and only program in the world offering multiple accreditations through one unified system. Cofounded by the ACCME and our colleagues in nursing and pharmacy, Joint Accreditation established the standards for IPCE planned by the healthcare team, for the healthcare team. The first two organizations were reviewed and granted Joint Accreditation in 2010.

Now, our IPCE community has grown to include:

- 10 professions
- 135 accredited organizations
- 57,000 educational activities each year
- 23 million interactions with healthcare professionals each year

Addressing Diversity, Equity, and Inclusion (DEI)

We are committed to fostering learning environments that promote health equity, inclusiveness, pluralism, diversity, equality of opportunity, and social justice. Accredited education has the opportunity and responsibility to be part of the solution, helping to navigate a path from empathy to understanding to action.

- Our Board of Directors convened a special Task Force on DEI to explore how the ACCME can facilitate meaningful change and advance the ideals of DEI in continuing education for health professionals. The Board of Directors will share their findings in 2022.
- We hosted a <u>webinar</u> that discussed strategies for advancing social justice and health equity through continuing education, featuring thought leaders from Rush University Medical Center and the American Medical Association.
- During several episodes of our podcast, <u>Coffee with</u> <u>Graham</u>, we addressed issues of health equity for marginalized communities.
- We created a dedicated webpage, <u>Advancing Social</u> <u>Justice Resources</u>, featuring resources for addressing DEI issues.
- In our Menu of Criteria for Accreditation with Commendation, we included a <u>criterion</u> that recognizes accredited providers for expanding their programs beyond clinical care education to address factors affecting the health of populations, including economic, social, and environmental conditions; access to care; and health disparities.

We have to move beyond just diversity and inclusion. They are important, but they are not where equity starts and ends. We need to begin to take the lead at the CME level to expand our language and to include broader concepts of equity and justice."

ACCME 2020 Meeting: Driving Change

When the World Health Organization declared the COVID-19 outbreak a global pandemic in March 2020, our education and outreach team quickly transitioned our in-person annual meeting to an all-virtual format in a matter of weeks. Our team produced a free, fully online experience that engaged more than 2,100 participants from over 1,100 organizations in 52 states/territories and 22 countries. Together, we addressed the important role of accredited education during the pandemic, shared resources and tips for virtual learning and working, and discussed how to better support clinicians and each other to during a challenging time.




ACCME 2021 Meeting: Embracing Change

EMBRACING CHANGE

By listening to our community of accredited providers and building on the success of the ACCME 2020 Meeting, our team produced

the ACCME 2021 Meeting in a completely online format. The 2021 meeting theme, Embracing Change, embodied the strength and resiliency of our accredited education community as we shared our successes, challenges, and key takeaways from providing continuing education throughout a pandemic.

For the first time, we introduced optional Working Groups, which offered participants an opportunity to collaborate with their colleagues to address a specific educational topic and develop a new resource for the accredited education community. The Working Groups presented a summary of their projects during the closing plenary session and disseminated their resources in the months following the meeting.



MORE EDUCATIONAL OPPORTUNITIES

STRATEGIC GOAL 5:

ADVANCE DATA **SYSTEMS**

We heard from stakeholders that an integrated, centralized data system is essential for reducing burdens on learners; better serving our accredited provider community; meeting the needs of credentialing, certifying, and licensing authorities; and increasing the value of accredited CME. The new, improved PARS is designed to achieve those goals.

Reflecting feedback from providers and other stakeholders, the new version of PARS features a modernized, user-friendly, streamlined interface for activity and learner reporting.

New benefits for CME providers include the options to:

- Display any current or future activities in CME Passport so they can be readily searched for and discovered by curious learners.
- Enter, track, and manage learner data for all accredited activities in one centralized system.

By entering activities prospectively, choosing to display them in CME Passport, and entering individual learner data, providers have the opportunity to:

- Increase the visibility of CME activities; reach a wider audience of learners.
- Eliminate the need to issue certificates at the completion of activities.
- Reinforce the value of activities to learners and other stakeholders.
- Decrease physicians' reporting burden giving them more time to focus on their patients, rather than paperwork.
- Support regulatory authorities by providing easier access to verified CME and Maintenance of Certification/Continuing Certification (MOC/CC) participation data.

Welcome to CME Passport

CME Passport is a free, all-in-one web application that enables physicians to find, track, and manage their CME.

Key features of CME Passport (formerly CME Finder):

- More activities: CME Passport displays any current or future activities that providers choose to include.
- · More search filters: Users can quickly search for accredited CME by activity format, date, types of credit offered, topic, location, keyword, specialty, and other details.
- Personalized accounts: Physicians can create a personalized account, enabling them to view and manage their reported CME and MOC/CC credits and generate transcripts for their state medical licensing board, employer, or other credentialing body.


ACCME and State Medical Boards Collaboration

The ACCME and State Medical Licensing Boards Collaboration enables CME providers to report physician participation in accredited CME to participating boards via PARS, with the goal of reducing burdens on physicians and simplifying the audit process for boards. The ACCME offers the service free of charge to medical boards, accredited providers, and physicians.

Currently, participating boards include:

- Medical Board of California
- Maine Board of Licensure in Medicine
- Maine Board of Osteopathic Licensure
- Maryland Board of Physicians
- North Carolina Medical Board
- Oregon Medical Board
- Tennessee Board of Medical Examiners

With the launch of the new version of PARS in November 2021, this service is now available to all state medical boards and all accredited CME providers.

ADVOCATE FOR CME SCHOLARSHIP

We support engagement in the scholarly pursuit of research in CME with the goal of advancing innovation and sharing best practices throughout the community.

Supporting Research

- We awarded a research grant to the Society for Academic Continuing Medical Education (SACME) to create toolkits on promoting best practices in educational design.
- We modified the evaluation questions in the new version of PARS to better align with outcomes models that are used in research.
- We offer researchers the opportunity to access anonymized ACCME data to support research that assesses the effectiveness of CME, identifies best practices in CME, and is in service to the overall CME enterprise.
- At our annual meetings, we invite participants to conduct research presentations and share lessons learned with their colleagues.
- The *Engages in Research/Scholarship* criterion in our commendation menu rewards providers for developing research projects.
