BUILDING ON PROGRESS

There are approximately 1,600 organizations accredited within the ACCME System across the country and the world. Our community is comprised of the entire range of institutions including hospitals and healthcare delivery systems, nonprofit membership organizations, publishing and education companies, schools of health sciences/medicine, insurance and managed-care companies, and government and military organizations.

Despite the unprecedented challenges created by the COVID-19 pandemic, accredited providers adapted nimbly, redesigning learning environments to offer critically needed skills and support to healthcare professionals and teams. Even with economic losses and a reduction in the number of activities, providers retained and even increased engagement by healthcare professionals. The ability to be so responsive reflects on the strength and capacity of the accredited education community. We at the ACCME recognized that our responsibility was to serve as a facilitator, offering accredited providers the guidance, resources, and flexibility that would enable them to meet the needs of healthcare professionals and teams during extraordinary times.

In 2020-21, our Board of Directors and staff engaged in a strategic review of the organization's operations and efficacy. As part of that review, the ACCME interviewed stakeholders and identified the following achievements:

- Elaborated a culture of interprofessionalism through our collaborations with nursing, pharmacy, and other colleague accreditors through Joint Accreditation.
- Expanded our online learning platform, ACCME Academy.
- Increased alignment between accredited CME and a growing number of certifying boards and state medical licensing boards.
- Supported an increasing array of organizations in achieving Accreditation with Commendation using the new criteria, reflecting the strength and diversity of our system and our capacity to more effectively demonstrate improvements in learning and outcomes.
- Unified data management for accredited providers and healthcare professionals in a centralized database of learning activities and completion records to allow the data to flow easily and reliably.
- Virtually convened our largest annual meeting of the accredited continuing education community.
- Developed leadership in international continuing education accreditation.

ACCME'S MISSION AND VISION

The ACCME is uniting the accredited continuing education community around our common mission: to assure and advance quality learning for healthcare professionals that drives improvements in patient care.

The ACCME accreditation system is recognized as a national model by federal and state government agencies, other healthcare accrediting bodies in the United States and around the world, and the profession of medicine. Our primary priority is to deliver on our commitment to ensure that we and the Recognized Accreditors (state medical societies)—as a united system—regulate and accredit with integrity to meet the expectations of the profession and continue to earn our trusted reputation among all our stakeholders.

Objectives:

- Promote the advancement of science and combat misinformation through our content validity efforts.
- Continue to oversee accredited providers to confirm compliance with ACCME requirements.
- Assure objective and consistent decision making.
- Maximize the accreditation equivalency of the Recognized Accreditors.
- Maintain a training infrastructure for ACCME volunteers.

ADVANCE EXCELLENCE IN ACCREDITED CONTINUING EDUCATION

Accredited providers must continuously evolve to meet the changing needs of their learning community. Delivering education is only part of the obligation—the education must ultimately help maintain or advance the quality of care. The ACCME is a trusted source of tools, resources, and training for education professionals. We plan to build on these strengths to enhance the impact of our system's accredited education, while supporting the measurement, reporting, and sharing of outcomes data.

Objectives:

- Leverage our accredited continuing education community to improve the quality and safety of medical practice and health outcomes.
- Encourage healthcare leaders and individual healthcare professionals to recognize that accredited continuing education:
 - ✓ Is an essential component of building and fostering a learning culture of continuous improvement for the organization.
 - ✓ Creates intellectual fulfillment and restores joy and meaning in practice.
 - ✓ Relieves healthcare professionals of administrative burden through simplification, alignment, and collaboration.
 - ✓ Creates and sustains functional interprofessional teams that learn together and take care of each other.
 - ✓ Supports collaborative work to address quality, safety, shared decision making, health equity, efficiency, and other strategic priorities for healthcare organizations.
- Foster and nurture a community of practice where accredited providers continuously improve their skills and strategies to support transformative learning (e.g., educational best practices, andragogy, implementation science).
- Drive the provider community to higher level outcomes to impact patient care and systems.
- Minimize barriers to innovation in educational delivery.
- Provide demonstrable value to health system leadership.

PROVIDE EXEMPLARY SERVICE

To deliver on our mission and reflect our values, we must offer exceptional support and resources to our accredited provider community. Accredited providers rely on the ACCME to facilitate their work and effort. Our community expects and deserves exemplary service across all aspects of the ACCME's operations—including communications, education, accreditation, recognition, administration—and an IT and data platform to bring these together seamlessly. An advanced data infrastructure supports greater engagement in the accredited continuing education system, builds learner self-awareness, helps healthcare professionals find and choose activities that fit their specific needs, facilitates self-reflection and the construction of an individualized educational plan, and serves as a powerful repository for generating and answering research questions.

Objectives:

- Provide transparency and understanding of our system to promote awareness, insight, and investment in continuing education.
- Listen to educators and stakeholders to identify areas of additional simplification in our accreditation standards and requirements.
- Support volunteers to maximize the efficiency and effectiveness of the service they provide to our accredited continuing education community.
- Simplify accredited continuing education reporting by healthcare professionals so they can focus on learning rather than obtaining credit.
- Support research designed to advance accredited continuing education.
- Foster and nurture an online community of practice for accredited continuing education professionals.

PROMOTE DIVERSITY AND INCLUSION

The accredited continuing education enterprise should support the evolution of the overall system by incentivizing and rewarding practices that demonstrate recognition of the need for, and value of, incorporating the issues of diversity, health equity, and inclusion into all aspects of accredited education.

Objectives:

- Create and support a culture of mutual respect, inclusivity, and equity at the ACCME, within the community of accredited providers, and for the faculty and healthcare professionals engaged in accredited continuing education.
- Facilitate understanding that incorporating the issues of diversity, equity, and inclusion into all aspects of accredited education will benefit healthcare professionals and the patients they serve.



DEMONSTRATE THE POWER OF COLLABORATION

Healthcare professionals often begin their careers without preparing for their roles as lifelong learners. The ACCME has a role in helping to advocate for, and support, the acculturation of humility and curiosity to ensure all healthcare professionals are ready to engage with accredited continuing education. Interprofessional continuing education helps to develop the behaviors and attitudes requisite to working in teams with colleagues from different health professions to deliver effective patient care. By harmonizing our standards and expectations across the continuum of healthcare education and professional development, between state and certifying board expectations, and across the professions, we will reduce barriers to the deployment of even more effective education that benefits all.

Objectives:

- Ensure healthcare professionals entering their careers are maximally prepared to be lifelong learners by collaborating across the continuum of professional development.
- Simplify information exchange between accredited providers and a variety of state licensing and certifying boards.
- Align accreditation standards to ensure education can cross professions unimpeded.
- Facilitate international collaboration through the implementation of shared standards.
