

How to Register Activities for Opioid Analgesic (OA) REMS:

Any accredited OA REMS activity that is available to learners during the current reporting period must be reported in PARS.

1. Start by logging in to PARS at https://pars.accme.org/.

2. As soon as the activity title, date, and activity format are known for your OA REMS activities, login to PARS and add the activities.



© 2023 Accreditation Council for Continuing Medical Education (ACCME[®]) Registering Opioid Analgesic (OA) REMS Activities in PARS 981_20230113 Individual activities that are part of a series that together cover the full Blueprint should each be assigned the same RPC Activity ID (the three digits following the RPC Grant ID) in PARS/JA-PARS so that ACCME recognizes them each as part of the series.

Proper entry of the RPC ID will enable ACCME to accurately identify and report data for each activity.

One important expectation of OA REMS-compliant activities is that the content covers the full FDA Education Blueprint ("Blueprint"). Some of the Blueprint content might be delivered live to the learners; some of it might be part of resource materials provided to the learners as part of the activity. How you choose to incorporate the full Blueprint is up to you and likely dependent on the needs of your learners and the format of your activity(ies).

If you offer a series of activities that, taken together, cover the full Blueprint, please know that you will be expected to only report learners for the OA REMS-compliant activities who engaged in all of the activities that make up the series. Of course, learners can earn CME/CE credit for individual activities and may not be expected to participate in the full series to receive CME/CE credit. However, when reporting your OA REMS learners, you will only report those learners who engaged with the full Blueprint.
