### For March 2025 Cohort Decisions Requiring a Progress Report

#### Determining the Milestones for your Organization's Progress Report

If the “**Next Decision Date**” on your March 2025 decision report is **November 30, 2025**, then your organization should adhere to the milestones applicable to an **8-month progress report review** process as indicated in the table below.

The Guide provides information about the content required for your progress report.

Due Upon Receipt of Invoice	Provider remits the progress report review fee.
May 7 2025	<b>Provider enters CME activity data.</b> If applicable to your noncompliance findings, enter available information about the CME activities that your organization has provided, or will provide, under the umbrella of your ACCME accreditation statement, from <b>April 1, 2025 – November 30, 2025</b> , into the ACCME's Program and Activity Reporting System (PARS) at <a href="https://pars.accme.org/">https://pars.accme.org/</a> .
May 21 2025	<b>ACCME notifies provider of activities selected for performance-in-practice review.</b> Based on the CME activity data you entered, the ACCME will select up to five activities for performance-in-practice review, if applicable to your noncompliance findings. The ACCME will inform the primary contact for your organization via email. Upon receipt, please review the list of activities and notify ACCME right away if you note any discrepancies or if the activities will not reflect the improvements you are implementing to demonstrate compliance.
June 4 2025	<b>ACCME notifies provider that the Progress Report Narrative and Performance-in-Practice Structured Abstracts are available in PARS.</b>
August 13 2025	<b>Progress Report Materials Submission Deadline.</b> Progress Report Narrative and Performance-in-Practice Structured Abstracts close in PARS.
December 2025	<b>ACCME notifies provider of the November 2025 Cohort progress report decision.</b>

The Guide provides information about the content required for your progress report.

September 3 2025	<b>Provider enters CME activity data.</b> If applicable to your noncompliance findings, enter available information about the CME activities that your organization has provided, or will provide, under the umbrella of your ACCME accreditation statement, from <b>April 1, 2025 – March 31, 2026</b> , into the ACCME's Program and Activity Reporting System (PARS) at <a href="https://pars.accme.org/">https://pars.accme.org/</a> .
September 17 2025	<b>ACCME notifies provider of activities selected for performance-in-practice review.</b> Based on the CME activity data you entered, the ACCME will select up to five activities for performance-in-practice review, if applicable to your noncompliance findings. The ACCME will inform the primary contact for your organization via email. Upon receipt, please review the list of activities and notify ACCME right away if you note any discrepancies or if the activities will not reflect the improvements you are implementing to demonstrate compliance.
October 1 2025	<b>ACCME notifies provider that the Progress Report Narrative and Performance-in-Practice Structured Abstracts are available in PARS.</b>
December 3 2025	<b>Progress Report Materials Submission Deadline.</b> Progress Report Narrative and Performance-in-Practice Structured Abstracts close in PARS.
March 2026	<b>ACCME notifies provider of the March 2026 Cohort progress report decision.</b>
